## Business:

- 1. The meeting was called to order at 7:10pm by Lauren H.
- 2. Pledges were led by Lauren H.
- 3. Treasurer's Report was read by McKynzie N. (print)

Kristin McFaul made a motion to approve the Treasurer's Report, seconded by Justin B.

- 4. Secretary's Report was read by Ava A.. A hard-copy of the minutes from the April meeting was made available, but had not been posted to the website yet. Sydney S. made a motion to accept the Secretary's Report, seconded by McKynzie N. The motion failed. Bella M. made a motion to table the minutes until the next Countywide meeting. Zoey M. seconded. Motion passed.
- 5. Updates and Events
  - a. Several JCHP youth attended the Ranch Horse Show on May 15<sup>th</sup>. Gracie L. reported that she learned about patterns showmanship, confirmation, horsemanship, etc. Jessica B. reported that she learned about not rushing through patterns and more accuracy.
  - b. Monday Night Lessons and Drill team continue. Make sure you sign up ahead using the link sent by UW Extension and sign in at the table when you arrive. The 5/29 lesson will be on English Equitation. Pam Seidl is willing to come to MNL and work with HH kids or youth that can't bring their horse that night on various topics.
