- 1. The meeting was called to order at 7:10pm by Jenn O.
- 2. Pledges were led by Celia O.
- 3. Jerry and Jenn met early this afternoon to discuss trips and trail rides. Per Jerry, youth must put in educational work to attend trips (i.e. livestock projects have points card they go to Louisville after gathering points, or judging/skillathon).
 - a. Kentucky Horse Park? Jerry stated that the Louisville cost about \$2K total. Jerry can order a vehicle or two that fit about 8 each. Adults must be approved leaders, have taken the overnight training, and have completed the driver authorization (which takes about 2 weeks). Youth of the same gender in rooms unless related.
 - Trail Rides: Jerry stated that adults must be approved leaders and in the correct proportion to youth, and follow safety protocols (2 approved leaders to 4 kids for high-risk activities).
 Washington and Sheboygan Counties do safety checks prior to rides (i.e. the youth demonstrate that they can safely handle horses).
 - c. Recommended to do point card or some alternative competition.
